Gallilee Springs Country Club Membership Agreement

The association created hereby is a private free association and shall not be considered, nor any action taken, creating a public accommodation.

It is intended that this property be a recreational family reserve. Each member agrees that they, and their family and guests, shall be subject to use restrictions and rules promulgated from time to time for the mutual benefit of each member and the welfare of the users of the property.

Each member has an affirmative obligation to report any unsafe conditions or uses existing or occurring on the premises. Each member has an affirmative obligation to protect and preserve the property.

Each member is presumed to be prudent and states that they shall be acknowledged prudent by acceptance of membership.

As a condition of membership, each owner shall accept responsibility for and abide by all rules and use requirements. Each member agrees to require their guest and invitees to engage in safe conduct and shall report unsafe conduct and conditions and work to actively remedy unsafe conditions and activities as they occur or become known. Each member shall be responsible for the conduct and safety of their family, guests and invitees, as they may be permitted access to the property

All memberships are an annual right of use and may not be transferred.

The annual cost of a membership in Galilee Springs shall be **\$50.00** for Timberwilde property owners.

Members shall pay **\$2.00** per guest per day. No member may have more than 5 guests per day without prior permission.

A family shall consist of all persons living within the household or children up to the age of 21 years old provided they remain lawfully eligible to vote at the address of the member.

Grandchildren of members, while residing at the members' home shall be considered members.

A Timberwilde resident who has failed to pay or failed to make arrangement for payment on the annual obligation of Timberwilde Homeowner Maintenance Fees shall

be ineligible for membership in Gallilee Springs.

In the event that a member engages in an ongoing and or non-casual violation of the rules, restrictions, agreements, commands of an authority charged with the health and safety of the members and guests, damages the property, fails to pay all charges when due or refuses to properly comply with the foregoing when asked, their membership shall be rescinded at the sole discretion of the board of governors. Upon rescinding of the membership their right to use is suspended and it is agreed that any entry into the property is a trespass.

The owner of the property shall appoint to serve, at its pleasure, a board of governors consisting of no less than three members who shall serve at the will of the owner for one year. The board of governors shall have no liability for any official act or any occurrence at the property. This board shall set all rules, regulations, determine membership status and other matters as deemed appropriate by the owner from time to time. It shall be the intention, duty and obligation of the board of governors, when established, to provide for the maximum enjoyment of the members and provide for the continual improvement and maximal maintenance of the facility and property.

Rules on the Use of the Property:

- All persons entering the property will register.
- There shall be no bottles, glass containers or other breakable objects used in or around the facility.
- The use of alcoholic beverages shall only be permitted by persons of legal drinking age, and only to the extent that no person may become intoxicated. Each person may only bring alcoholic beverages for their personal consumption. No beverage may be taken into the water, on the slide, waterfall or upon any facility of the pool.
- No person or group may be loud, obnoxious, profane, obscene, nude, or lewd.
- There shall never be less than 3 persons at the facility when any one person is in or on the pool or its facility. At least one of such persons shall be at least 18 years of age and a member.
- No person may prohibit the free use of another person rightfully using the facility.
- All children under the height of 4'6" or 12 years of age shall be supervised by an adult and the related or associated member at all times. Such adult persons shall have full and complete responsibility for their conduct, safety and compliance with the rules, regulations and authorities.
- All guests will abide by the rules of the facility and the member whose guest they are shall be responsible to inform the guests of such rules and enforce adherence to the rules by their guests.
- No one under the age of 21 may be at the facility after sunset without a parent or guardian present. However, at an approved special use the sponsoring member may hire a certified life-guard for every 20 persons under the age of 18 in attendance and this rule may be waived provided that no alcoholic or intoxicating

substances are present.

- No amplified sound or other devices that can be heard beyond 30 feet from their source shall be utilized in or around the facility.
- Parking and use of motorized vehicles is prohibited except where designated for parking.
- Horses, dogs, cats and other animals shall not be allowed in the water or within the swimming area.
- The property shall be closed on Sunday prior to noon. No one may enter the water after 30 minutes past sunset.
- All signs, placards, and other warnings shall be complied with.
- No unauthorized entry is permitted into the equipment and storage room for any reason whatsoever.
- There shall be no climbing on the rocks or the waterfalls.
- The slide may only be used by one person at a time. The slide may only be accessed by the stair case. Any person caught scuffling with another on the staircase, landing or slide will be suspended from use of the facility. No person may slide down the slide until they are sure that the prior slider is clear below or 10 seconds elapses. The slider shall holler "clear below" and listen for a response prior to sliding. The slider will not linger below the slide and upon entering the water move away from the outfall of the slide as soon as possible.

Special Events:

When inviting more than 5 guests, arrangements must be made 15 days in advance. The cost for such special events shall be determined at that time based upon the intended use. A \$100.00 deposit will be paid in advance. If at the end of the event there was no additional clean-up required by Gallilee Springs Country Club grounds maintenance personnel, 100% of the deposit will be refunded. A request for special use may be denied' for any reason without explanation. Generally any permissible special use shall be a family oriented activity. The member shall provide a written request for a special use describing the special use, the times, anticipated number of people, types of beverages, if any, to be served and any other requested information at the time.
